The 8,800 SF condominium unit is occupied by Mobile Therapy Centers of America ("Tenant"). The building was constructed in 2006. The Tenant has been in business for over 16 years and has been at this location for just over 2 years. This location is critical to the Tenant's business and serves as the local HQ for the surrounding markets.

This opportunity allows an investor to purchase a medical office condo that is occupied by a growing behavioral health and therapy company in a rapidly growing industry, which is projected to exceed \$132.4 billion by 2027. The Tenant, Mobile Therapy Centers of America, has been occupying this location since 2021 with a fresh 5-year lease to be signed at close of escrow. The lease features rare 3% annual increases. The Tenant is on a modified gross lease whereby the Tenant pays for their own utilities and ongoing maintenance of HVAC. The roof is maintained annually, under a maintenance contract paid by the HOA, and included in Condominium Fees.

Crystal Lake is located 45 miles northwest of Chicago, in McHenry County, a short drive from O'Hare International Airport and near several major highways and interstates. The Union Pacific rail line provides easy access to Chicago, and the Route 14 corridor is filled with big-name retailers and restaurants, interspersed with many local specialty shops and dining places. Crystal Lake is a regional leader in planning, growth management, and municipal services. Their residents enjoy high-quality programs and services at one of the lowest municipal tax rates in the area. Crystal Lake boasts wonderful schools, including two of the very best public school systems in the region, Elementary School District 47 and Community High School District 155, and the home of McHenry County College. The most common employment sectors for those who live in Crystal Lake, IL, are Manufacturing (13.3%) Retail Trade (12%), Educational Services (10.2%), and Health Care (10.1%).

The affluent area enjoys a low crime rate and a high-performing schools, making crystal lake a popular choice for families. 






DEMOGRAPHICS AVERAGE HH INCOME
