Crystal Lake is located 45 miles northwest of Chicago, in McHenry County, a short drive from O'Hare International Airport and near several major highways and interstates. The Union Pacific rail line provides easy access to Chicago, and the Route 14 corridor is filled with big-name retailers and restaurants, interspersed with many local specialty shops and dining places. Crystal Lake is a regional leader in planning, growth management, and municipal services. Their residents enjoy high-quality programs and services at one of the lowest municipal tax rates in the area.

- Crystal Lake boasts wonderful schools, including two of the very best public school systems in the region, Elementary School District 47 and Community High School District 155, and the home of McHenry County College.
- The most common employment sectors for those who live in Crystal Lake, IL, are Manufacturing (13.3%) Retail Trade (12%), Educational Services (10.2%), and Health Care (10.1%).
- The affluent area enjoys a low crime rate and a high performing schools, making crystal lake a popular choice for families. Currently, just 7% of the population in Crystal Lake sits below the poverty line.
- The city's namesake is just one of many lakes and parks providing venues for outdoor activities like boating, swimming, biking, and golf. The main street in the historic downtown district is the city's cultural hub, with excellent dining, shopping, and nightlife.




